### **Dumpster Day - Anne**

SSC & Republic really stepped up. Over 4K lbs were removed from York's homes, yards, streets and alleys. We had a record 4 toilets.

## Rock Hill Revitalization - Steve & Laine (CoB Parks)

"Security Attendants" unofficially Park Ambassadors. A new program to monitor park security, safety, health and more. The program is part of Park Operations. The program started in "Community Parks" and is expanding into "Neighborhood Parks".

#### Park Planning

- PRO Plan and Level of Service (part of the City Comprehensive Plan). "Neighborhood Parks" are a subsection. Map in presentation illustrates "Level of Services" to surrounding areas. Currently gaps are most visible in the north with smaller gaps appearing south of the middle of the City.
- PEP Tool. First time that socioeconomic factors are included in planning. Also looking for greatest need, as usual. Density is another planning factor. Using MF housing, general density, average income and need to target repairs and upgrades.
- Rock Hill is in the top five parks being reviewed regarding playground safety and repair needs. Age of
  installation is a top priority in selecting parks for repair & upgrades.

### Rock Hill Watering Plan & Work Party - Anne & John

#### Discussion covered:

Wide range of uses, typically, previously, anywhere up to \$5,000. However, new system under Mayor Fleetwood did not have a specified top dollar amount. Rather it pooled \$40,000 for all neighborhoods over a biennium. New biennium amount not announced as yet.

- Looking for ideas.
- "Century Homes" (signs for homes/buildings older than 100 years).
  - o Chris, Tom, Mark & Élan were interested in taking such an idea on.
  - o Web map.
  - o Historic Photos.
  - Plaques per home.
  - Plaques per block with QR codes to web site.

Rock Hill was discussed in particular. Options for facilitating certain activities were noted. Comments from YNA noted. "Considerations" from Parks were noted, including maintenance/sustainability, geography, stormwater, ecology and cost.

Next steps include applying PEP Tool to Neighborhood Parks, playground audits. **Parks Director, Nicole Oliver visiting Harriet Spanel and Rock Hill Parks August 5 at 2pm and 3:30pm respectively to get neighborhood feedback.** Identify in capital budget; design & construction.

Construction's planned completion is in 2023.

Q&A followed. One item noted is closing volunteer egress to Lakeway. Anne questioned if water could be setup using the old service from the demolished house. Steve said that could be looked into and that Parks is favorable to having water at parks for desired uses as well as for cleaning. Q: How do we get more folks to that upper area? (rhetorical). "Q: Maybe we should have more than one hoop?" Asked by some not at meeting.

Currently budgeting for 2023 & 2024. Putting money in budget(s) for playground equipment.

Shooting for RH playground work completed June 2023 but looks more like fall 2023.

Q: Any update on the former Entry Arbor? A: It is in the ground and staying near the plum tree – Anne.
